

## Take Home Naloxone Program: Information for PBS-Registered Community Pharmacies

### Getting Started

- **REGISTER** for the Take Home Naloxone (THN) Program through the Pharmacy Programs Administrator (PPA) portal (<https://www.ppaonline.com.au>).
- Order and pay for naloxone through your normal wholesaler.
- **Ensure a minimum level of stock is always kept on hand of all naloxone formulations.**

### Supplying Naloxone

- **Any individual** at risk of experiencing/witnessing an opioid overdose, e.g. requests naloxone OR is **IDENTIFIED BY PHARMACIST** as high risk OR is a high risk **MATOD client**.
- Provide **FREE, NO PRESCRIPTION** naloxone product based on preference:
  - If an individual prefers a less invasive intranasal form, supply **NYXOID® NASAL SPRAY**.
  - If individual prefers an injectable (IM) product, supply **PRENOXAD® PRE-FILLED SYRINGE**.
  - Only supply **NALOXONE AMPOULES** if specifically requested.
- Provide **BRIEF ADVICE** and a copy of the **CLIENT HANDOUT** leaflet.

### Claiming

- The information required to be entered in the PPA portal is:
  - Date of naloxone supply.
  - Formulations and quantities of naloxone supplied (maximum two).
  - Staff designation (e.g. Pharmacist).
  - Client consents to providing de-identified data
  - Whether this is an initial supply or a refill
  - If a refill is provided, provide the reason for refill supply:
    - My THN was used on me
    - My THN was used on someone else
    - My THN was given to someone else to keep
    - My THN is lost, damaged or expired.
- **CLAIM THE COST PLUS DISPENSING FEE THROUGH THE PPA PORTAL**

**A maximum of two times the PBS quantity of naloxone can be supplied per visit.** There is **NO** maximum on the number of visits as each one is entered as a separate supply claim in the PPA portal, as per the table below:

PRODUCT	MAXIMUM QUANTITY YOU CAN SUPPLY PER VISIT
<b>NYXOID® intranasal spray<sup>1</sup></b> naloxone 1.8 mg/actuation nasal spray, 2 x single dose sprays	Two packs of two single-use nasal sprays <b>(Total of four single-use nasal sprays)</b>
<b>PRENOXAD® pre-filled syringes</b> naloxone hydrochloride 1mg/mL, 2mL syringe Supply an additional three x 23 gauge (blue) 1 inch to 1 ½ inch needles per syringe and a sharps disposal container.	Two packs of one syringe <b>(Total of two pre-filled syringes)</b>
<b>Naloxone Juno, Naloxone SXP or Naloxone Hydrochloride (DBL) ampoules</b> 400 mcg/mL, 5 x 1mL ampoules Supply 5 needles (23 gauge (blue) 1 inch to 1 ½ inch) and 5 syringe barrels (1mL to 3mL) per pack, and a sharps disposal container.	Two packs of five ampoules <b>(Total of ten ampoules)</b>

The national Take Home Naloxone (THN) Program provides access to **free naloxone** from participating sites (such as community pharmacies and hospitals) to **anyone** at risk of experiencing or witnessing an opioid adverse reaction. **NO PRESCRIPTION REQUIRED.** Naloxone is a lifesaving, fast-acting, temporary, opioid antagonist that was used **FOUR times a WEEK** in South Australia between July 2022 – June 2023. **Emergency medical treatment is still required.** There is **NO RISK OF MISUSE**. <sup>1</sup> An additional brand, **Nyxoïd® (UK)**, has been temporarily approved to import and supply in Australia under section 19A (s19A) of the Therapeutic Goods Act 1989 until 19 July 2024.
