Opportunities

- Renal services capacity opportunity to expand capacity, there is a waiting list
- TPPP 12 month placement on renal (as opposed to 6 month rotation)
- Transitional care packages have staff and facilities to increase services
- Complex discharges capacity to take on greater volume, and take pressure off Wallaroo

Initiatives

- Palliative care room refurbishment underway, community groups contributed funds to the project
- Integrating Aboriginal health information into staff induction consulting now on the design of information to share with staff

Risk and challenges

- Increasing emergency presentations and retrievals
- Hard to support inexperienced staff
- Minimal staffing model and fixed funding
- Still needing to meet RAC standards when not a RAC site
- Lack of dedicated mental health area
